Bough Beech reservoir is situated in the Weald of Kent between Sevenoaks and Edenbridge.

Organising Authority: The Bough Beech SC.

1. Rules

1. The series will be governed by the rules as defined in the World Sailing Racing Rules of Sailing (RRS) 2021 - 2024, the RYA prescriptions, This Notice of Race (NOR) and the Sailing Instructions (SIs).
2. In the event of any conflict between these Rules, those of the Sailing Instructions shall prevail.
3. The exoneration penalty (and the advisory and RYA Arbitration) of the RYA Rules disputes procedures will be available.
4. RRS 26; RRS 29.2; RRS 35; RRS 40.2; RRS 60.1(a); RRS 64.2; RRS A4. RRS A5; A9(a); Race signals ICF "L" and Appendix S 11.1. are subject to change. The changes will appear in full in the Sailing Instructions. The Sailing Instructions may also change other racing rules.
5. **PUMPING (Finns Only)** - Should the RO consider the wind to be above 10 knots the 'O' flag will be displayed with the preparatory signal for the Finn fleet and unlimited downwind pumping will be permitted. Once displayed it will remain in place for that race and be reviewed for each race thereafter.

2. Safety Regulations

1. [DP] Adequate personal buoyancy must be worn by all persons at all times when afloat and on the pontoon jetty, except briefly while adjusting clothing or personal equipment. This changes RRS Rule 40 and the preamble to Part 4, and BBSC Club Byelaw E8.
2. Buoyancy must be appropriate to the size and weight of the individual and the activity in which they are engaged and must be worn in accordance with the manufacturer's guidelines. It is the responsibility of each individual, or in the case of a child, their parent, guardian or support person to ensure this.

3. Eligibility & Entry

1. The series is open to Devoti D-Zero, Finn and Supernova dinghies. Boats may only be entered using the official online entry.
2. All Entrants must be members of an RYA affiliated club or personal members of the RYA.
3. All Streaker entrants must also be members of the Streaker Class Association for the current year.
4. Eligible boats may enter either by completing the online entry form available here: [Open Events – Bough Beech Sailing Club \(boughbeechsc.org.uk\)](https://www.boughbeechsc.org.uk) with payment online prior to the Friday before the event; or by entering on the day at the club, with payment also being online. We would encourage entry and payment prior please in order to have a better idea regarding numbers.
5. Entries will be accepted up to 1015hrs on the race days for those entering on the day.

4. Fees

1. Required fees are as follows: £15 per boat.

5. Schedule

1. Registration will take place in the club house from 09.30 hrs. If you have registered online, you do not need to do anything further.
2. A briefing will be held at 10.15hrs
3. Schedule of Races:

Class	Number of races per day
Finn	4 (First warning signal 10:57hrs)
D-Zero	4 (First warning signal 11:00hrs)
Streaker	4 (First warning signal 11:03hrs)

4. The number of races sailed on the day will depend on weather conditions and at the discretion of the race committee. The race management may vary the starting order depending on wind strength and direction.
5. No warning signal for any race will be given after 15.15 hrs.

6. Sailing Instructions

- 6.1 The sailing Instruction will be available on the club website and on the official notice boards in the clubhouse.

7. Class Flags

7.1 The following class flags will be used;

Finn:	Class Flag
Devoti D-Zero:	Flag H
Streaker:	Flag R

8. The Courses

8.1 The courses to be sailed will be defined in the sailing instructions and displayed at the club.

9. Scoring

9.1 The scoring system of RRS Appendix A.4 will apply (see RRS 90.3).

9.2 A minimum of one race is required to be completed to constitute the series.

9.3 The number of races a boat may exclude from her score (or the number of races to count) will depend upon the number of races completed as follows:

Number of races completed	Races to count
4 races completed	3 races to count
3 races completed	3 races to count
2 races completed	2 races to count
1 race completed	1 race to count

10. Radio Communications

10.1 Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

11. Prizes

11.1 The Bough Beech Organising Committee will award prizes at its discretion.

12. Advertising

12.1 Boats may display advertising supplied by the organising authority.

13. Risk Statement

13.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. **Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.** The organising authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

14. Insurance

14.1 It is a condition of entry that each participating boat shall be insured with valid third-party liability insurance with a level of cover adequate to cover all third-party claims.

15. Rights and Copyright

15.1 By participating in this event, a competitor automatically grants to the Organising Authority the right in perpetuity to make, use and show at their discretion any motion pictures, still pictures and live, taped or filmed television and other reproductions of him/her during this long series event and of all of his/her material related to the championship, without compensation.

16. Data Protection

16.1 In order to manage the events, information provided by competitors will be held on a database. ADDITIONAL INFORMATION.

Protection against invasive species

All participating boats will be expected to have met the Club's protective procedure against "invasive species" before entering the water boards property.

Camping

Camping is not permitted.

Parking

Parking is available in the club car park. Boats should be rigged in the car park and walked down on their launching trolleys to the slipway.

Security

Valuables should not be left in the changing rooms or visible in cars.

Dogs

Under the terms of the Sutton and East Surrey Water Company byelaws, Dogs are not permitted on the premises of the Club, its grounds or car parks.
